#### 1. Brief facts of the complaint

1.1 Sh. Devender Kumar has filed a grievance in PGC regarding shifting of High Tension wire over Rattan Vihar, ABC Block, Prem Nagar – 1, D & E Block, F-G Block, Prem Nagar – 1, J Block Prem Nagar – 2, K 1 Block, K Block, V Block, W Block, Tripathi Enclave Prem Nagar – 2, Kirari, Suleman Nagar, Delhi – 110086.

## 2. <u>Facts emerged during the proceedings</u>.

2.1 Ms. Gurpreet Kaur, Sr. Executive (TPDDL) was present in the hearing and submitted an Action Taken Report stating therein that:-*"In pursuance to the advice of the Commission issued vide order PGC/2020/Power/05/11924 dt 04/01/2021, TATA Power-DDL has again written a letter on 13<sup>th</sup> Jan 2021 to concerned utility of Haryana State Electricity Board apprising them of the proceedings and of the subject grievance and for taking necessary steps by them for ensuring safety of the said network. The said communication/letter dated 13<sup>th</sup> Jan 2021 is enclosed herewith as Annexure A.* 

TATA Power-DDL has already clarified its position in its previous communications to the Hon'ble Commission and apprised that the grievance does not pertain to TATA Power-DDL, as the network belongs to another electricity board, namely Uttar Haryana Bijli Vikas Nigam Limited of HSEB, and the company has no power to encroach upon the said network, it is again requested that the Commission may relieve TATA Power-DDL from the said matter as the company has no power or jurisdiction with respect to the network lines in issue and has made all due efforts to contact the concerned utility in order to assist the Commission in this regard.

We trust that the aforesaid reply has clarified our position and the Hon'ble Commission may pass appropriate orders keeping in view the stated facts." 2.2 The complainant was not present in the hearing. Perusal of the record reveals that he has not attended any of the hearings held in the Commission.

#### 3. Directions

- 3.1 As the complainant does not seems to be interested in pursuing the case and perpetually remained absent during the hearings held in the Commission, it is beyond rationale in keeping the case pending in the Commission.
- 3.2 In view of the above, the case stands disposed of in the Commission.
