1. Brief facts of the case

Shri Sanjay, filed a complaint stating that he filed an on-line application for issue of SC Certificate in favour of his son. Registration of application was given as 90510000639976, vide an acknowledgement slip in which it was mentioned that within 07 days, he shall visit the office of Tehsildar (Punjabi Bagh). On 21.12.2020, he visited the office of Tehsildar (Punjabi Bagh) and showed original documents. He was told that the certificate will be issued within 15 days, but the certificate was not issued and he received an SMS informing that the application has been rejected as details in the application are not properly filled up. He was told to re-apply with proper details. The complainant has mentioned that he did not re-apply and has requested for issued of certificate in favour of his son.

2. Facts emerged during the proceeding:

2.1 *The complainant was not present at the hearing.*

2.2 Shri Praveen Kadian, NT/Punjabi Bagh was present. He filed a status report dated 7.7.2021 which mentions that the complainant had applied for issue of two SC certificates, vide application Nos. 90510000620772 & 90510000639976. SC certificate in r/o of application No. 90510000620772 was issued on 9.10.2020. The application No. 90510000639976 was rejected as the applicant had wrongly filled the on-line application and there is no provision for editing in the on-line application. As such, the

applicant may be asked to apply afresh so that the same can be processed for issue of SC Certificate.

3. **Directions**

3.1 The application No. 90510000639976 has been rejected by Revenue Department as the application was wrongly filled. No editing can be done in the same. As such, the complainant is advised to file fresh application for issue of Caste Certificate in r/o of his son.

3.2 With the above advice, the instant grievance case stands closed in the Commission.
