#### 1. Brief facts of the case

1.1 Shri Suraj Pandit filed a complaint stating that recovery of Rs. 35,000/-+ 8% interest has not been executed by District Central.

The Joint Labour Commission vide letter No.F.23/12/Imp./ND/19/2437-39, dated (not legible) forwarded the Recovery Certificate for execution to District Collection Officer/District Magistrate , District Central, Revenue Department. The complainant further mentioned that he submitted an affidavit with SDM affirming that the Judgement Debtor /owner of M/s. Kaka Engineering Works resides at first floor of the given address and has a scooty with number DL-8S-GL-4728. A notice was issued by the office of SDM. The counsel of Judgement Debtor contacted him and there was an agreement. He was twice called in the office of the Counsel but the payment was not made.

## 2. Facts emerged during the proceeding:

2.1 Shri Aashesh Kumar, DEO, Office of SDM (Kotwali) informed that recovery of an amount of Rs. 48,400/- has been executed from the Judgement Debtor. He filed copy of demand draft, from the Judgement Debtor in favour of

Shri Suraj Pandit, complainant and claimant. The amount of Rs. 48,400/-includes the awarded amount of Rs. 35,000/- plus interest from the date of award till the date of realisation. He informed that the complainant was informed to collect the demand draft who stated that he will collect the same on 3.11.2021, Wednesday, which is his working holiday.

2.2 Shri Rakesh Kumar, ASI/PS Sarai Rohilla submitted a status report informing that in respect of non-bailable warrant issued by Executive Magistrate, Shri Gurmeet Singh, Judgement Debtor was arrested and presented before SDM/Kotwali. Also, the car No. DL-10 CE-8163 was seized. On payment of Rs. 48,400/- by the Judgement Debtor, on the directions of SDM/Kotwali, the warrant of arrest was cancelled and the car was released.

#### 3. **Directions**

- 3.1 As bank draft of Rs. 48,400/- in favour of the complainant has been received, the long pending award by Labour Department has been executed. The complainant is advised to collect the same from the office of SDM/Kotwali.
- 3.2 Good efforts on the part of SDM/Kotwali and SHO/PS Sarai Rohilla is appreciated, due to which the grievance of the complainant has been redressed, though after intervention of this Commission. This is brought to the notice of DM/Central and DCP/North.

As the grievance has been redressed, the grievance case is disposed of.
