**ORDER**

Whereas Sh.Sanjay Kumar Sharma, Under Secretary, M/o Skilled Development, Govt. of India was appointed as Administrator for a period of 180 days under Section 37(1) in respect of Delhi Mercantile Co-Operative Urban Thrift & Credit Society Ltd. vide order of even No. dated 27/08/2020 by the Competent Authority.

And whereas the tenure of Sh.Sanjay Kumar Sharma as Administrator, Delhi Mercantile Co-Operative Urban Thrift & Credit Society Ltd. has expired on 22/02/2021.

And whereas the Competent Authority has approved to extend the tenure of Sh.Sanjay Kumar Sharma as Administrator, Delhi Mercantile Co-Operative Urban Thrift & Credit Society Ltd. for a period of 90 days under Section 37(1)(b) of DCS Act.

And whereas as per the order of even no. dated 27/08/2020 the Ex-Managing Committee had also been directed to hand over the charge of the record of the Society/relevant documents within 07 days from the issue of the order. However, the Ex-Managing Committee has handed over the records of the Society to the Administrator on 13/02/2021. Consequently, the election process of the Society has to be initiated by the Administrator.

Now therefore, the Competent Authority has approved the appointment of Sh.Sanjay Kumar Sharma as Administrator-cum-Returning Officer for conducting elections within the period of 90 days in respect of Delhi Mercantile Co-Operative Urban Thrift & Credit Society Ltd. The elections shall be conducted in terms of Rule -53 readwith Schedule - II appended to DCS Rules, 2007.

This issues with the prior approval of Competent Authority.


