**ORDER**

And whereas, the last election of the society was held on 26.03.2017 and the tenure of the present Managing Committee was expired on 25.03.2020. Further Sh. Pramod Kumar Singh was appointed as Returning Officer vide order dated 04.03.2020 to conduct the election of Management Committee of the Society but the election could not be held due to the outbreak of Covid-19 and there was restriction on gathering. Further Sh. Pramod Kumar refused to work as Returning Officer in the Society as he is pre-occupied in some other works.

Now therefore, I, Satish Kumar Gupta, Assistant Registrar (GH/Sec-III) hereby convey the approval of the Competent Authority to appoint Sh. Manoj Kumar, Section Officer, A.R Department, Delhi Sachivalaya, New Delhi as Returning Officer in, Friends Circle Co-operative Group Housing Society Ltd., (Regn. No. 924/GH) under section 35 (1) of DCS Act, 2003 with immediate effect to conduct the election of the Managing Committee of the society within 90 days from the issue of this order. The expenses of election will be met out from the society's fund.

He will be paid 6,000/- (Rupees Six Thousand Only) as honorarium from the society's fund for conducting the election within 90 days of issue of this order.

This issues with the prior approval of Competent Authority.


