This order shall dispose of the proceedings initiated vide Show Cause Notice dated 25.09.2020 issued u/s 118(9) of DCS Act, 2003.

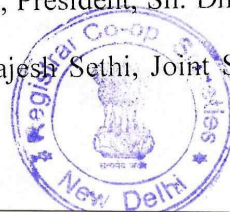

It is also a fact that nothing has been placed on record to show the orders have been complied with.


