ORDER U/S 35 (5) OF DCS ACT, 2003

Whereas, Eklavya Vihar Co-operative Group Housing Society Ltd. (Regn. No.564/GH) is registered with this department under the provisions of DCS Act, Rules & Bye-laws framed thereunder;

And whereas, Sh. Narendra Kumar Jain, President of Eklavya Vihar Co-operative Group Housing Society Ltd. has resigned due to his personal engagements. Vide letter dated 15.03.2021, he has stated that it is very difficult to devote time for society affairs. Therefore, he has decided to tender his resignation from the post of President of the Managing Committee of the society with immediate effect. He has further requested this Deptt. to arrange to initiate the process of holding fresh election at the earliest for the office bearers of the Managing Committee as per the policy of the DCS Act/latest bye-laws as applicable. And whereas, Treasurer & 03 Executive members have also resigned vide letter dated 16.03.2021 vide which they have stated that since the President Sh. Narendra Kumar Jain has resigned, it is not possible to continue their services and take care of the society affairs. Hence, they have decided to submit their resignations from the Managing Committee with immediate effect. They have requested to arrange early election for electing the new Managing Committee as requested by the President. (Copy enclosed)

And whereas, it is submitted that 05 out of 06 Managing Committee members including President & Treasurer have resigned, and as per clause 23 of model bye-laws, it should consist of at least 05 members in the Managing Committee. The last election of the said society was held on 21.10.2018, Audit of the completed upto financial year 2018-19 and Auditor has been appointed for financial year 2019-2020 by the Audit branch of this office.

And whereas, the Registrar Co-operative Societies has approved the name of **Mr. Bajrang Lal, Retd. DANICS** for the appointment of **Administrator-Cum-Returning Officer** under Section 35 (5) of DCS Act, 2003 in Eklavya Vihar Co-operative Group Housing Society Ltd. (Regn. No.564-GH) with immediate effect. A remuneration of **₹.10,000/-** (Rupees Ten Thousand Only) per month and Traveling Allowance applicable as per circular dated 29.09.2016 (copy enclosed) shall be paid from the fund of the Society and to hold the election of the Managing Committee of the Society within stipulated period of 90 days from the date of appointment as Administrator-Cum-Returning Officer.

The Ex-Managing Committee of Eklavya Vihar CGHS Ltd. is hereby directed to handover the charge of the record of the Society/ relevant documents to the Administrator-Cum-Returning Officer immediately under intimation to this office within 07 days from the issue of this order.
