Whereas, the Sahyog Cooperative Group Housing Society Ltd., Plot No.52, Sector-09, Rohini, Delhi-110085, is registered with this Department vide Regn. No.393/GH.

And whereas, a representation has been received from the Secretary of the society, wherein, it has been requested to appoint an Election officer to conduct the elections in the society.

And whereas, in view of the above circumstances, the Secretary-cum-Registrar Co-operative Societies has appointed Sh. R.C. Antil, Administrative Officer, GNCT of Delhi, Administrator-cum-Returning Officer in the aforesaid society u/s 35(5) of DCS Act, 2003 to conduct election in the Society.

Now, therefore, I, Ajit Kumar, Asstt. Registrar (Section-VII/Housing), O/o RCS hereby convey the approval of the Secretary-cum-Registrar Co-operative Societies to appoint Sh. R.C. Antil, Administrative Officer, GNCT of Delhi, Administrator-cum-Returning Officer in the aforesaid society u/s 35(5) of DCS Act, 2003 to manage the day-to-day affairs of the society and also to conduct election in the Society within a period of ninety days from the date of issue of this order. He is entitled to receive Rs.10,000/- (Rs. ten thousands only) per month as honorarium, out of the society funds.

The other expenses of the election will be met out from the funds of the society. The election of the Managing Committee of the aforesaid society shall be conducted as per the guidelines for the elections available in Rule 53 and of Schedule-II of DCS Rules, 2007.

Further, the Ex-President/Ex-Secretary, MC members of the society are hereby directed to handover all the records/documents of the society to the Administrator-cum-Returning Officer within 07 days from the date of receipt of this order.
