**ORDER**

Whereas, the Shivaji Co-operative Group Housing Society Ltd., Sector-14, Plot No. 4/1, Rohini, Delhi-110085 is registered with this Department vide Regn. No.65/GH.

And whereas, Sh. Pawan Kumar Chopra had been appointed as Administrator-cum-Returning Officer vide this office order dated 30.11.2017.

And whereas, Sh. Pawan Kumar Chopra has been working as Administrator-cum-Returning Officer for more than three years.

And whereas, in view of the above circumstances, the Secretary-cum-Registrar Co-operative Societies has appointed Sh. Manoj Kumar, IAS(Retd.) as Administrator-cum-Returning Officer in the aforesaid society u/s 35(5) of DCS Act, 2003 in place of Sh. Pawan Kumar Chopra.

Now, therefore, I, Ajit Kumar, Asstt. Registrar (Section-VII/Housing), O/o RCS, hereby convey the approval of the Secretary-cum-Registrar Co-operative Societies to appoint Sh. Manoj Kumar, IAS(Retd.) as Administrator-cum-Returning Officer in the aforesaid society u/s 35(5) of DCS Act, 2003 to manage the day-to-day affairs of the society and also to conduct the election in the Society within a period of ninety days from the date of issue of this order. He is entitled to receive Rs.10,000/- (Rs. ten thousands only) per month as honorarium plus travelling allowance, out of the society funds.

The other expenses of the election will be met out from the funds of the society. The election of the Managing Committee of the aforesaid society shall be conducted as per the guidelines for the elections available in Rule 53 and of Schedule-II of DCS Rules, 2007.

Further, the Ex-Administrator-cum-Returning Officer of the society is hereby directed to handover all the records/documents of the society to the newly appointed Administrator-cum-Returning Officer within 07 days from the date of receipt of this order.
