ORDER

Whereas, the Sarva Kalyan Coop. G/H Society Ltd., S-524, School Block, Shakarpur, Near TVS Room, Delhi-110092 is registered with this Department vide Regn. No.681/GH.

And whereas Sh.Y.Srinivasa Rao (Dy. Controller of Accounts) was appointed Administrator-cum-Returning Officer in the society vide order of even number dated 21.01.2020. However, he tendered his resignation from the post vide letter dated 10.06.2021 due to pre-occupation of work and other personal reasons.

And whereas, in view of the above circumstances, the Competent Authority has appointed Shri R.K.Mudgal (Retd. Asstt. Director), Administrator-cum-Returning Officer in the aforesaid society u/s 35(5) of DCS Act, 2003.

Now, therefore, I, Ajit Kumar, Asstt. Registrar (Section-VII/Housing), O/o RCS hereby convey the approval of the Competent Authority to appoint Shri R.K.Mudgal (Retd. Asstt. Director), Administrator-cum-Returning Officer in the aforesaid society u/s 35(5) of DCS Act, 2003 to manage the day to day affairs of the society and also to conduct the election in the Society within a period of ninety days from the date of issue of this order. He is entitled to receive Rs.10,000/- (Rs. Ten Thousands only) per month as honorarium, out of the society funds:

The other expenses of the election will be met out from the funds of the society. The election of the Managing Committee of the aforesaid society shall be conducted as per the guidelines for the elections available in Rule 53 and Schedule-II of DCS Rules, 2007.

Further, the Ex-President/Secretary and Ex- Administrator-cum-Returning Officer of the society are hereby directed to handover all the records/documents of the society to the newly appointed Administrator cum Returning Officer within 07 days from the date of receipt of this order.
