ORDER U/S 35 (5) OF DCS ACT, 2003

Whereas, Delhi State Indian Bank's Co-operative Group Housing Society Ltd. (Regn. No. 641ND/GH) is registered with this department under the provisions of DCS Act & Rules framed there under;

And whereas, 04 Managing Committee members of the society addressed to President/Secretary of the society vide letter dated 21.01.2021 have resigned and have stated that *since there is complete lack of co-ordination/cooperation among Management Committee members & not adhering basic guidelines issued by RCS for the interest of members so we decided to resign from the committee and requested them to accept this letter as formal resignation from the Managing Committee with immediate effect* (Copy enclosed).

And whereas, it is also submitted that the last election of the said society was held on 25.08.2019 consisting 07 members in the Management Committee of the society.

And whereas, it is submitted that the 04 out of 07 Managing Committee members have resigned and as per clause 23 of model bye-laws it shall consists of at least 05 members in the Managing Committee. Since the managing committee presently has only 03 members which is below the minimum number of members i.e. 05 as mandated under its bye-laws.

And whereas, the Registrar Co-operative Societies has approved for the appointment of **Dr. Surender Kumar Bhandoria, Addl. Director, Deptt. of Education** as Administrator-Cum-Returning Officer under Section 35 (5) of DCS Act, 2003 in Delhi State Indian Banks's Co-operative Group Housing Society Ltd. (Regn. No.641ND-GH) in place of Manjeet Rai Arora, Retd. DANICS with immediate effect. A remuneration of **₹.10,000/-** (Rupees Ten Thousand Only) per month and Traveling Allowance applicable as per circular dated 29.09.2016 (copy enclosed) shall be paid from the fund of the Society and to hold the election of the Managing Committee of the Society within stipulated period 90 days from the date of appointment as Administrator-Cum-Returning Officer.

The Ex-Managing Committee of Delhi State Indian Banks's CGHS Ltd. is hereby directed to handover the charge of the record of the Society/ relevant documents to the **Dr. Surender Kumar Bhandoria, Administrator-Cum-Returning Officer** immediately under intimation to this office within 07 days from the issue of this order.
