Whereas, The Shivam Coop. (U) Thrift & Credit Society Ltd., 1/50, Ganga Apptts., Lalita Park, Main Vikas Marg, Laxmi Nagar, Delhi-110092, is registered with the department vide registration No.43(U) under the provisions of DCS Act/Rules.

And, whereas Sh. Suniti Kumar Gupta was appointed as Administrator-Cum-Returning Officer u/s 35(5) of DCS Act, 2003 vide this Office order of even number dated 05.08.2021 to manage the affairs of the society and to conduct the election of Managing Committee of The Shivam Coop. (U) Thrift & Credit Society Ltd. However, Sh. Suniti Kumar Gupta expressed his inability to function as Administrator-cum-Returning officer in the aforesaid society due to personal reason.

Now, the Secretary-cum-Registrar Co-operative Societies, GNCT of Delhi, in exercise of the powers vested in him under DCS Act & Rules has approved to appoint Sh. I.S. Gulati, I.T.O. (Retd.), as Administrator-cum-Returning Officer, in The Shivam Coop. (U) Thrift & Credit Society Ltd., under section 35(5) of DCS Act, 2003 to manage day to day affairs of the society and to conduct election within ninety days from the date of his appointment as per provisions of DCS Act, 2003 & DCS Rules, 2007 in the society. He is entitled to receive Rs. 10,000/- (Rupees Ten Thousand Only) per month as honorarium and conveyance to be paid from the society's funds.
