ORDER U/S 35 (5) OF DCS ACT, 2003

Whereas, Durga Pooja Co-operative Group Housing Society Ltd. is registered vide registration No.670-GH dated 29.09.1983 with this department under the provisions of DCS Act & Rules and Bye-Laws of the Society;

And whereas, the letter/resignation dated 12.07.2021 (copy enclosed) received from Sanjeev Kumar Kakkar, President of Durga Pooja CGHS Ltd. vide which he has *submitted his resignation from the post of President of Managing Committee of the society and requested this office to pass appropriate directions for election of new President in accordance with law;*

And whereas, another letter/resignation dated 20.07.2021 (copy enclosed) received from 06 members of the Managing Committee of the society namely Sh. Ved Singh Dhankar (Vice-President), Smt. Alka S Bharwal (Secretary) Smt. Sarita Dalal (Treasurer), Sh. Pramod Gupta (MC Member), Smt. Prem Lata Verma (MC Member) & Sh. Sanjay Paliwal (MC Member) vide which they have stated that *they don't want to continue in the Management Committee. They are therefore, tendering their resignation from Management Committee with immediate effect. Sh. Sanjeev Kumar Kakkar, President, has already tendered his resignation on 12.07.2021. Kindly appoint an Administrator till further election for smooth functioning of the society.;*

And whereas, the last election of the society was conducted on 02.05.2021 and submitted the copy of check list for financial year 2019-2020 issued by the Assistant Registrar (Audit) vide diary No.117 dated 05.08.2020 (copy enclosed);

And whereas, the Registrar Co-operative Societies has approved for the appointment of **Mr.Rajender Babu Shukla, Retd. Grade-I** as Administrator-Cum-Returning Officer under Section 35 (5) of DCS Act, 2003 in Durga Pooja Co-operative Group Housing Society Ltd. (Regn. No.670-GH) with immediate effect. A remuneration of **₹.10,000/-** (Rupees Ten Thousand Only) per month and Traveling Allowance applicable as per circular dated 29.09.2016 (copy enclosed) shall be paid from the fund of the Society and to hold the election of the Managing Committee of the Society within stipulated period 90 days from the date of appointment as Administrator-Cum-Returning Officer.

The Society is hereby directed to handover the charge of the record of the Society/ relevant documents to Administrator-Cum-Returning Officer immediately under intimation to this office within 07 days from the issue of this order.
