ORDER U/S 35 (5) OF DCS ACT, 2003

Whereas, Cabinet Secretariat Co-operative Group Housing Society Ltd. is registered vide registration No.35-GH with this department under the provisions of DCS Act & Rules and Bye-Laws of the Society;

And whereas, vide letter dated 09.10.2021 Sh. Atamjit Singh informed that three Management Committee members were elected in the GBM held on 06.06.2021 and two Managing Committee members i.e. Secretary & Treasurer have resigned from their posts on 01.10.2021. Accordingly, Sh. Atamjit Singh has requested to appoint an Administrator-Cum-Returning Officer in the society to constitute new Managing Committee in the society.

And whereas, the Registrar Co-operative Societies has approved for the appointment of **Mr. Suniti Kumar Gupta, Retd. DANICS Officer** as Administrator-Cum-Returning Officer under Section 35 (5) of DCS Act, 2003 in Cabinet Secretariat Co-operative Group Housing Society Ltd. (Regn. No.35-GH) with immediate effect. A remuneration of **₹.10,000/-** (Rupees Ten Thousand Only) per month and Traveling Allowance applicable as per circular dated 29.09.2016 (copy enclosed) shall be paid from the fund of the Society and to hold the election of the Managing Committee of the Society within stipulated period 90 days from the date of appointment as Administrator-Cum-Returning Officer.

The Ex-President/Secretary of the Society is hereby directed to handover the charge of the record of the Society/ relevant documents to Administrator-Cum-Returning Officer immediately under intimation to this office within 07 days from the issue of this order.
