Whereas, Dera Ismail Khan Co-operative House Building Society Ltd. is registered vide registration No.160NW-HB with this department under the provisions of DCS Act & Rules and Bye-Laws of the Society;

Whereas, Mr. R.P. Aggarwal, Retd. ADM (North-East), who was appointed as Administrator-cum-Returning Officer vide this Office Order dated 10.09.2021, has resigned from the post of Administrator-cum-Returning Officer on personal reasons.
