ORDER

This order shall dispose of the Appeal u/s-19 of the Right to Information Act, 2005 filed by Sh. CR Tiwari, appellant in respect of RTI application ID No. 341 dated 26/07/2021.

The RTI application dated 26/07/2021 pertains to the Society u/s 139 of DCS Act, 2003 read with rule 165 of DCS Rule, 2007 as the questions asked are specific in nature and is dealt by the Society. Appeal is disposed of with the above direction accordingly.
