The undersigned was appointed as a Returning Officer by the Managing Committee of the THE DELHI TRANSPORTER'S CO-OP, GROUP HOUSING SOCIETY LTD. Plot No. 2, Sector-2, Phase-1, Dwarka, New Delhi-110075 society vide letter dt. 3-10-2021 by passing the resolution in the General body Meeting of the Society on 26/9/2021 and conformed in the managing committee of the society on 10-10-2021 to hold the election of the managing committee of THE DELHI TRANSPORTER'S CO-OP, GROUP HOUSING SOCIETY LTD. Plot No. 2, Sector-2, Phase-1, Dwarka, New Delhi-110075.

After acceptance of the appointment as a Returning Officer in reference of the said letter, the undersigned made the request to the President/Secy. of the society vide letter dt. 5.10.2021 to provide the required documents along with list of enrolled members as well as list of defaulter members to the undersigned to conduct the election of the managing committee of the society under the provision of DCS Act./Rules. In response of the said letter, President/Secy. of the society provided the required documents vide letter dt. 17.10.2021. After received the required documents, the list of enrolled members along with defaulter members was displayed on the notice board of the society as well as Registrar Cooperative Societies vide letter dt. 19.10.2021. The undersigned issued the Agenda Notice dt. 08.11.2021 for conduct the election of the managing committee of the society in a Special General Body Meeting which was held on 12.12.2021 at 10.00 A.M. at the premises of the Society in THE DELHI TRANSPORTER'S CO-OP, GROUP HOUSING SOCIETY LTD. (JOY APPARTMENT) Plot No. 2, Sector-2, Phase-1, Dwarka, New Delhi-110075 and dispatched the agenda notices to 45 members of the society through speed post and rest of members of the society who are residing in society complex personally delivered by hand and forwarded two copies to the society in which one copy of agenda notice to place on the notice board of the society and one copy for record for the Society. Agenda Notice also placed on the notice board of the Returning Officer. Copy of the agenda notice forwarded to Asstt Registrar (Section-IIGH) O/o the Registrar Cooperative Societies for record.

As per agenda programme, the nomination forms were issued by the undersigned on 28.11.2021 free of cost to the interesting members who want to contest the election of the Managing Committee of the society. Only 12 nomination forms were issue by the undersigned. The nomination forms duly filled up were received by the undersigned on 29.11.2021. which were filed by only 11 (Eleven) members of the society for one post of President, one post of Vice President, and 9 (Nine) posts of members of the managing committee of the society in which includes two posts reserved for women members. As per agenda programme, the nomination forms were scrutinized on 30.11.2021 and all nomination forms were found valid and the list of valid contesting candidates was displayed on the notice board of the society on 30.11.2021 at 5.00 P.M. As per agenda programme, on the date of the withdrawal of the nomination forms on 01.12.2021, no request application for withdrawal of the nomination form was received. The final list of contesting candidates was displayed on the notice board of the society on 02.12.2021 at 12.00 P.M

After completing all the procedural formalities as per the Special note of Agenda Notice dt.08.11.2021, the Special General Body Meeting of the society was held on 12.12.2021 at 10.00 A.M. at the premises as per venue of agenda notice THE DELHI TRANSPORTER'S CO-OP, GROUP HOUSING SOCIETY LTD. (JOY APPARTMENT) Plot No. 2, Sector-2, Phase-1, Dwarka, New Delhi-110075 The quorum of the meeting was observed up to 10.30 A.M. same day .Due to not fulfill the quorum of the meeting up to 10.30 A.M. The said meeting was adjourned for 15 minutes and again started at 10.45 A.M. on the same day i.e. 12.12.2021 at the same place as per schedule of the programme of the agenda notice.

As per final contesting candidates list after scrutinized and withdrawal of the nomination forms there is no contest for one post of President, one post of Vice President, and 9 (Nine) posts of members of the managing committee of the society in which includes two posts reserved for women members .Therefore, the undersigned announced the result and declared elected unopposed the members of the managing committee of the aforesaid society for a term of three years under the provision of DCS Act. 2003 read with DCS Rules 2007 as per detail given below:
