Order under Section 139 of DCS Act, 2003

This order shall dispose of the appeal dated 31.07.2019 filed by Sh. Pankaj Kalra, Appellant, in respect of his application dated 14.03.2019 seeking information on 13 points from CBI (MHA) Employees Coop. T/C Society Ltd. The appellant has stated in the appeal that society sent a vague reply through an e-mail on 09.04.2019 wherein it is mentioned that "it is intimated that Assistant Director (T&C) has issued order U/s 35(5) of DCS Act, 2003 vide No. 47/399-(U)/Sec-II/Coop./T&C/2019/1948 dated 25.03.2019 appointing Dr. Pramod Kumar as Administrator-cum-Returning Officer under Section 35(5) of DCS Act, 2003 with immediate effect for conducting the election of the Managing Committee of the society. Further, Assistant Director (T&C) has directed President/Secretary of the society to handover all the relevant documents of the society to Dr. Pramod Kumar, Administrator-cum-Returning Officer immediately. Therefore, it is informed that your above mentioned 07 applications will be considered by the new Managing Committee."

Notices were issued and in its furtherance, the matter was heard on 02.02.2021, 18.03.2021 by the then Jt. Registrar. Thereafter, the matter came up for hearing in the Court of undersigned on 13.09.2021. During hearing, Sh. Pankaj Kalra, Appellant was present in person. Respondent Society was represented by Sh. Satish Joshi, CA alongwith Sh. Neeraj Kumar, Vice-President and Sh. Ashish Dagar, Secretary. The Appellant has stated that he was not satisfied with the information dated 12.04.2021 provided by the Respondent Society. It was directed by the undersigned that on or before next date of hearing, the Respondent

Society shall bring the source of the information and the Appellant shall inspect and seek relevant information. Thereafter, the matter came up for hearing on 01.11.2021, Sh. Neeraj Kumar, Vice President alongwith Sh. Satish Joshi, CA were present on behalf of the Respondent Society. None appeared from the Appellant. As per the direction given on 13.09.2021, the Respondent Society brought the records of the Society. As the Appellant was not present to inspect the records, notice was issued to him as final opportunity to appear before the undersigned otherwise ex-parte decision will be taken. During hearing on 29.11.2021, Ms. Seema Kalra, wife of the Appellant with her authority letter was present. Also present Sh. Lalit Kumar Sharma, President alongwith Sh. Satish Joshi, CA on behalf of the Respondent Society. Two opportunities were given to the Appellant to appear before the Court on 01.11.2021 & 29.11.2021 to inspect the relevant records but he failed to appear before the Court.

In view of the above, it is observed that the Respondent Society has already given its reply vide letter dated 12.04.2021 and moreover, despite providing opportunities the Appellant failed to appear before the Court and could not inspect the files.

Hence, the appeal of the Appellant is dismissed accordingly.
