ORDER

By this order, I shall dispose of the appeal dated 30/12/2020 under section 91 of DCS Act 2003 filed by Shri Vinod Bhatia against the New Development Cooperative Group Housing Society Ltd. for not transferring membership in his name in r/o flat no. M1B and issue a share certificate despite numerous requests of Appellant.

The case was heard on 11/3/2021 by the then Joint RCS which was attended by the Shri Anil Sharma, President alongwith Shri S.K.Saini, Secretary of the Respondent Society. None was present for the Appellant in the hearing. However, a letter dated 01/3/2021 was received

from the Appellant through post. In the aforesaid letter, the Appellant stated that he is not interested to continue the case and his case may be treated as withdrawn and closed. The Appellant also confirmed the same and the file was kept for order by the then Joint RCS. It is gathered that formal orders could not be issued by the then Joint RCS since he was deployed as the Returning Officer by the Dte. Of Gurudwara Elections & also deployed in management of Covid-19 and subsequently transferred out of department as Additional District Magistrate, DC Office during the lockdown.

The Appellant has recently pursued the matter vide letter/reminder dated 02/12/2021 and requested for issue of orders as per proceeding dated 11/03/2021.

I have gone through the complete case file. In view of the position stated above, the appeal dated 30/12/2020 of the Appellant is dismissed as withdrawn.

The case file may be returned to the Assistant Registrar(Section-5/GH).
