**ORDER UNDER SECTION 86 (1) OF DCS ACT, 2003**

This order shall dispose of the application dated 27.10.2020 made by applicant society, bearing this office Diary No.26359 dated 28.10.2020.

The applicant society, made an application to this office for approving the action of expulsion of respondent under DCS Act and Rules, resolved by the Managing Committee on 04.10.2020, on the ground that said members are persistent defaulters in respect of the society dues. The applicant society issued three expulsion notices to the member on 17.02.2020, 02.06.2020, and 08.08.2020 and no reply has been received from the respondents in regards of served notices. The applicant society issued a letter dated 16.09.2020 to the respondents for providing an opportunity for hearing on 03.10.2020 before the Managing committee in society's office. The Managing Committee of applicant society vide its meeting dated 04.10.2020 resolved to expel the members from the membership of the society, and referred the matter to this office for seeking approval thereof, under DCS Act and Rules.

The matter was examined and proceedings were initiated under Section 86 of DCS Act, 2003. Accordingly, notices were issued to all the concerned for providing opportunity.

During the hearing on 04.01.2021 society represented by Sh. Bharat Singh Sehrawat, President alongwith Sh. J.N. Gupta, Advocate. President filed a letter dated 18.12.2020 wherein he has submitted that members namely Sh. L. R. Suman, Membership No. 42 and Sh. C.P. Saini, Membership No. 66. Sh. C.P. Singh Verma, Membership No. 80, Sh. Balesh Aggarwal, Membership No. 106, and Sh. Rajender & Narender, Membership No. 131 have cleared their dues of amount in default.

Society has further prayed that the proposal for expulsion of said members may kindly be treated as withdrawn.

In view of the declaration given by the society that the said members have cleared their dues and requested to withdrawn the proposal of expulsion, I do hereby dismiss the proposal of expulsion of the respondents.

Hence case is disposed off accordingly.

The case file be sent to the concerned Assistant Registrar Cooperative Society/ Section to keep the same on record.
