ORDER

Whereas, Vasant CGHS Ltd. Plot No.06, Vasant Apptt., Mayur Vihar, Ph-I, Delhi-110091, is registered with the department vide registration No.344/GH under the provisions of DCS Act/Rules.

And, whereas Sh. G.S. Chaturvedi, Special Commissioner (Retd.), was appointed as Administrator-Cum-Returning Officer u/s 35(5) of DCS Act, 2003 vide this Office order of even number dated 07.01.2021 to manage the affairs of the society and to conduct the election of Managing Committee of Vasant CGHS Ltd. However, Mr. G.S. Chaturvedi shows his inability to join as Administration in the concerned society due to personal reasons.

Now, the Secretary-cum-Registrar Co-operative Societies, GNCT of Delhi, in exercise of the powers vested in him under DCS Act & Rules, appoint Sh. R.C. Kesharwani, DANICS (Retd.) Govt. of NCT of Delhi as Administrator-cum-Returning Officer, in Vasant CGHS Ltd. under section 35(5) of DCS Act, 2003 to manage day to day affairs of the society, conduct of audit, settlement of outstanding issues, if any, and to conduct election within ninety days from the date of his appointment as per provisions of DCS Act, 2003 & DCS Rules, 2007 in the society. He is entitled to receive Rs. 10,000/- (Rupees Ten Thousand Only) per month as honorarium and conveyance to be paid out of the society's funds.

This issues with the prior approval of the Competent Authority.
