Whereas, CCIE Employees Co-operative Group Housing Society Ltd. (Regn. No.44/GH) is registered with this department under the provisions of DCS Act, Rules & Bye-laws framed thereunder:

And whereas, received from Secretary of CCIE Employees Co-operative Group Housing Society Ltd. vide which she has informed that the President of the Managing Committee of CCIE Employees CGHS Ltd. Mrs. Vipla Bhataria has already submitted her resignation on 09.10.2020 (Copy enclosed) and sent the same to RCS office by Speed Post. She/Secretary has also informed that other members of the Managing Committee have also resigned and all the resignations have been forwarded to RCS office by speed post on 16.10.2020. She has further requested this office to kindly depute an Administrator to look after the society affairs and also requested to advice the President (Ex) to be present while handing over the charge to the coming Administrator/R.O.

And whereas, the last election of the said society was held on 03.11.2019 and election result received from Returning Officer, Mr. Suraj Bhan consisting 11 members in the Management Committee of the society out which 07 members of Managing Committee have resigned including President, Vice-President, Secretary & Treasurer and 03 Managing Committee members on various dates and as per clause 23 of model bye-laws it shall consists of at least 05 members in the Managing Committee. Since the managing committee presently has only 04 members which is below the minimum number of members i.e. 05 as mandated under its bye-laws.

And whereas, the Registrar Co-operative Societies has approved for the appointment of **Mr.Mahesh Kumar Gupta, Retd. DANICS** as Administrator-Cum-Returning Officer under Section 35 (5) of DCS Act, 2003 in CCIE Employees Co-operative Group Housing Society Ltd. (Regn. No.44-GH) with immediate effect. A remuneration of ₹.10,000/- (Rupees Ten Thousand Only) per month and Traveling Allowance applicable as per circular dated 29.09.2016 (copy enclosed) shall be paid from the fund of the Society and to hold the election of the Managing Committee of the Society within stipulated period 90 days from the date of appointment as Administrator-Cum-Returning Officer.

The Ex-Managing Committee of CCIE Employees CGHS Ltd. is hereby directed to handover the charge of the record of the Society/ relevant documents to the Administrator-Cum-Returning Officer immediately under intimation to this office within 07 days from the issue of this order.
