ORDER

Whereas, the Naveen Kunj CGHS Ltd., Pocket-6, Plot No.22, Sector-1A, Dwarka, New Delhi-110034 is registered with this department vide Regn. No.2009(GH) under the provisions of DCS Act and Rules.

Whereas, an order under section 61 of DCS Act, 2003 was issued vide order no.47/2009/GH/Sec-V/2020/104 dated 23.07.2020 appointing Shri Manmeet Singh Walia, Asstt. Legal Advisor (Law Deptt.) as Inspection Officer in Naveen Kunj CGHS Ltd. to look into the complaints received in this office from Sh. Sudhir Chandra and Sh. Kamal Dudani on various allegations including adoption of wrong electricity charges calculation methodology, President working on the post despite having been resigned, alleged roughly hiking maintenance charges among others.

And whereas, Inspection under section 61 of DCS Act, 2003 has been completed and as per Inspection Report dated 12.11.2020 (copy enclosed) of the Inspection Officer Shri Manmeet Singh Walia, Asstt. Legal Advisor (Law Deptt.) the allegations made in the complaint are found proven.

Now, therefore, I, Surinder Narang, Assistant Registrar (Sec-5/H) hereby convey the approval of Competent Authority to appoint Sh. J.P. Sharma, Retd. Adhoc DANICS as Inquiry Officer under section 62 of DCS Act, 2003. The Inquiry Officer shall fix the responsibility of person/office bearer of the society on the findings given by the Inspection Officer Mr. Manmeet Singh Walia. Quantum of lapses/misappropriation, if any, shall also be fixed. The society shall pay Rs.15,000/- (Rupees Fifteen Thousand only) as remuneration to I.O. from the funds of the society for conducting the inquiry. The inquiry shall be completed within a period of 60 days of issue of this order.

This issues with the prior approval of the Competent Authority.
