ORDER U/s 40(iii) of DCS Act, 2003


The office of RCS has received representation from the Delhi Cooperative Urban T & C society Ltd. regarding the approval of expulsion of member Sh. Maheshwar Prasad Yadav S/o Sh. Bhutae Yadav (Membership No. 21726) from the society U/s 40 of DCS Act, 2003. In their representation society has stated that a written complaint against Sh. Maheshwar Prasad Yadav of misbehaviour/misconduct done with staff members and management of the Manager, Pitampura branch vide dated 13.10.2017. The management committee discussed the said complaint in its meeting held on 15.10.2017 and thereafter issued a notice under Rule 31 of DCS Rules, 2007 read with Section 40 of DCS Act, 2003 vide No. F-21726/Notice/DCUS/2017/2857 dated 25/10/2017 to give him an opportunity to explain his position against a written complaint received from Manager of the society. Further management committee unanimously passed a resolution and expelled Sh. Maheshwar Prasad Yadav membership No. 21726 from the primary membership of the society with immediate effect.

Accordingly court proceeding were started by worthy RCS and on 15.01.2021 worthy Secretary Cum RCS has transferred the court file to Addl. RCS and summon has been issued to appear before the undersigned on 31.03.2021 at 11.00 AM.

During hearing on 31.03.2021 the society was represented by Sh. Parshu Ram Gupta, CEO. None present for the respondent and Sh. Parshu Ram Gupta, CEO has submitted a document dated 31.03.2021 wherein society has stated that " Sh. Maheshwar Prasad Yadav has submitted his resignation from the membership of the society vide his application dated 09.01.2021, after adjusting all his deposit in loan and interest and his membership was closed w.e.f 09.01.2021. and further Sh. Parshu Ram Gupta, CEO requested to withdrawn the case.

Hence case is disposed of as withdrawn.

The case file be sent to the concerned Assistant Registrar Cooperative Society/ Section to keep the same on record.


