
The financial up-gradation will be purely personal to the employee concerned and show no relevance to their seniority position. The pay of the employees under this scheme will be fixed under the provision of FR 22(1)(a)(1). The financial benefit allowed under the MACP Scheme shall be final and no pay fixation benefit shall accrue at the time of regular promotion i.e. posting against a functional post in the higher grade. Further this financial up-gradation is subject to all the terms and conditions as enumerated in DOPT O.M 35034/3/2008-Estt.(D) dated 19.05.2009 read with the DOPT O.M. of even no. dated 16.11.2009.

However, the grant of higher pay scale is subject to the undertaking that in the event of overpayment, which may be detected at a stage, the same will be recovered from their pay.

The employee concerned is allowed to exercise his/her options, if any, under FR(22)(1)(a)(1) to get his/her pay fixed in the higher post/grade pay either from the date of his/her promotion/up-gradation or from the date of his/her next increment viz. 1st July of the year within 1 month of the issuance of the order granting the financial up-gradation under the MACP Scheme.

The Head of office concerned are requested to ensure before issuing the pay fixation order that the particulars of officials as indicated in order is in conformity with his/her service record and also that no vigilance case is pending against him/her as on date.
