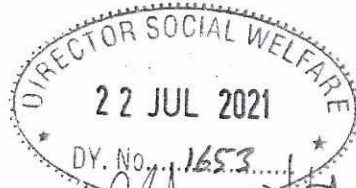

The Human Immunodeficiency Virus and Acquired Immune Deficiency Syndrome (Prevention and control) Act, 2017" mandates designating Complaints Officer as per provisions vide section 21 of the Act in all establishments having one hundred or more persons (20 or more in case of health care setting). Complaint Officer shall dispose of complaints of violations of the provisions of the Act in the establishment in accordance with the rules notified by the Ministry of H&FW, Govt. of India. Excerpts of relevant provisions are annexed.

Hence it is requested that necessary instructions may be issued to all subordinate departments/bodies/establishments under your jurisdiction to implement the provisions of the Act and to designate Complaints Officer & placing a link of Notified Central Rules ('[http://naco.gov.in/sites/default/files/egazette HIV AIDS Act_0.pdf](http://naco.gov.in/sites/default/files/egazette_HIV_AIDS_Act_0.pdf)') on website of your Department and to share details of Complaint Officers with DSACS (delhisacs1@gmail.com).
