Further consequent to the remapping of AWCs of 95 projects in 11 Districts vide order no. F.NO.76/(497)/NNM/DWCD/ICDS/2017-18/6383 dated 25/06/2019, The Competent authority has now decided to further extend this agreement w.e.f **1st December 2020 to 28th February 2021** or completion of ongoing EOI whichever is earlier in the ICDS Projects as per the following.
