Thirteen(13) posts of Welfare Officer/ Social Workers to be filled on contract basis had been created in the Department of Women and Child Development vide order No. F 61(266)/DWCD/DD(CPU)/2010-11/9374-384 dated 18.07.2011 for operationalisation of Special Juvenile Police Units (SJPU) in each Police District of UT of Delhi and are being continued on year to year basis with the concurrence of Finance Department. In continuation to order F. No. 61(266)/DWCD/DD(CPU)/2011-12/24624-31 dated 03.02.2020, sanction of Competent Authority is hereby conveyed for continuation of these thirteen(13) posts for the period w.e.f. 01.04.2021 to 31.03.2022.

The continuation is subject to the conditions that provision of funds to meet the expenditure on remuneration of the staff is made in the Budget and funds as allotted in Budget are released by the respective authorities during the relevant period of time.
