Minutes of the Meeting of the GIA Committee of the Deptt. of WCD constituted for the year 2020-21 for during this meeting a total of 14 presentation by the concerned NGOs for consideration and finalization received under the scheme of 'The grants to social welfare institutions / organizations by the government of national capital territory of Delhi Rules, 2008' was held on 26.03.2021 at 3:30 PM under the Chairmanship of Director, WCD.

GIA Committee of the Deptt. of WCD constituted for the year 2020-21 for during this meeting a total of 14 presentation by the concerned NGOs for consideration and finalization received under the scheme of 'The grants to social welfare institutions / organizations by the government of national capital territory of Delhi Rules, 2008' was held on 26.03.2021 at 3:30 PM under the Chairmanship of Director, WCD.

The points discussed are as under :-


1. Sh. Ravi Kant Jha, (Office Secretary) represented Bhartiya Adim Jati Sevak Sangh, he mentioned that NGO is working for girls and having Institutional Settings. During discussion the clarification was sought by DO(Central). The project proposals for GIA for F.Y 2020-21 is approved by the GIA Committee as the ongoing project of NGO for which GIA has been sanctioned in the past as also on the basis of inspection report submitted by DO(Central). However, the amount has granted is restricted to the amount sanctioned for the last financial year 2019-20. The Committee gave directions that for next time the concerned NGO should apply for funds in ICPS Scheme.
2. There was no representation from Society for Promotion of youth and masses (SPYM) – Pardabagh and Society for Promotion of youth and masses (SPYM) –Delhi Gate, Jain Mandir. However, these two proposals were rejected for not having registration under Juvenile Justice Act, 2015.
3. There was no representation from Society for Promotion of youth and masses (SPYM)- Sewa Kutir, Kingsway Car. The proposal was rejected because the concerned NGO is receiving grant-in-aid under ICPS scheme, further suppression of facts misleading information given by the concerned NGO render the institution ineligible.


