ORDER

In pursuance of Order no. F.No.6(105)/WCD/Admn./PF/ 2016/ 2019-20/806-818 dated 16.04.2021 regarding extension of engagement of Shri Hari Prasad Sharma, retired Controller of Accounts/Integrated Financial Adviser (DoB – 09.03.1960 and DoS – 31.03.2020) from this Department, as CONSULTANT against a vacant post of the post of Jt. Director (Tech.) in the Department of Women & Child Development, for a period of One (01) Year from the date of his joining or till the post of Jt. Director (Tech.) is filled on regular basis, whichever is earlier, for both, Department of Women & Child Development and Department of Social Welfare, Shri Hari Prasad Sharma submitted his joining report on 16.04.2021 (F/N).

2. Accordingly, Shri Hari Prasad Sharma is taken on the strength of the Department as CONSULTANT for a period of one (1) year from 16.04.2021 (F/N) to 15.04.2022 (A/N). His engagement will be governed by the term and conditions contained in OM issued by Finance Department, Government of NCT of Delhi, vide no. F.20/4/ 2015-AC/204-208 dated 4 Dec 2015.

3. His engagement as Consultant is against vacant post of Joint Director (Technical) in the Department of Women & Child Development.

4. Monthly consolidated remuneration, payable to Shri Hari Prasad Sharma as Consultant shall be regulated as per said OM dated 4/12/2015. As such monthly consolidated remuneration payable to Shri Hari Prasad Sharma, Consultant will be as Last Pay *minus* Basic Pension plus DA at the applicable rate.

5. Monthly consolidated remuneration payable to Sh. Hari Prasad Sharma, Consultant (DWCD & DSW) during the said period of one year, from 16.04.2021 (F/N) to 15.04.2022 (A/N), will be as under and be drawn against vacant post of Joint Director (Technical) – A Level 12 post:

- (ii) Basic Pension w.e.f. 01.04.2020 (Evidence Attached) : Rs.52,800.00
- (iii) Monthly consolidated remuneration as Consultant as per OM dated 4 Dec 2015 referred to above {(i) – (ii)} : Rs.52,800.00 plus Dearness Allowance as applicable from time to time
