- ✓ Have adequate space and basic facilities at home.

You can offer Fit facility for Group Foster Care

To provide:-

- >Short term care;
- Medical care treatment and specialized; treatment;
- >Psychiatric and mental health care;
- >De-addiction and rehabilitation;

DIf the facility can:-

- >Meet the basic standards of care and protection to the child;
- Provide basic services to any child placed with it;

Education;
Vocational training and skill development.
