Subject: Income Tax Declaration for the F.Y. 2021-22 (Asstt. Year 2022-23).


According to the income tax guidelines, income tax is deductible annually for each financial year commencing from 1st April and ending on the 31st March. The Employer has responsibility to deduct income tax from the salary of employees and deposit in Government Account before the due date as prescribed by the Income tax department.

All officers/officials working at WCD (HQ) may declare their investments/savings/income from other sources in the enclosed format along with the documentary proofs in support of rebate to be claimed for the financial year 2021-22 (Asstt. Year 2022-23).

All individuals are requested to submit an undertaking stating therein that they will adopt Income Tax provision under New Regime OR shall continue with the Old Regime for the current Financial Year 2021-22, failing which it will be presumed that the individual is adopting old regime of Income Tax provisions.

The duly filled in declaration form shall furnish to the DDO, Accounts Section (HQ) by 01.12.2021 positively, otherwise the Income Tax, as per available information, shall be deducted from the individual's salary from the month of December 2021, January 2022 and February 2022.
