Whereas Poshan Tracker is being monitored by Ministry of Women and Child Development, Government of India for the real time monitoring of the ICDS services and deliveries. It has been observed that there are lots of gaps and discrepancies in data being uploaded in the app which is very serious issue and needs to be rectified at earliest and the authenticity of the entries is not being regularly monitored at the District and Project Level.

It is conveyed several times that entire gap in the mismatch of data entries in different categories i.e. Registered beneficiaries, AWC infrastructure, Growth monitoring (SAM, MAM children), Low birth weight, Anemic details must be removed to provide true picture of implementation status of POSHAN Scheme, but still the gap is existing in all parameters. Whereas the inaccuracies and inconsistencies can bring lot of embarrassment to the department as the information is in the public domain and also being monitored by the Ministry of Women & Child Development, GOI.

To improve the monitoring and authenticity of the data, it is hereby directed to all officers and officials posted at Department of Women & Child Development/District Offices/Project Offices and Institutions to visit 3 AWCs nearby to their home on every Saturday and send the visit report in attached format on poshan.dwcd@gmail.com on Monday by 5:00 pm.
