ORDER

Whereas an OA No. 2424/21 titled Sudesh Devi Vs. DSSSB & Ors. was filed in Hon'ble CAT.

WHEREAS, in this OA the Applicants had sought following relief:

- 1. Set aside/quash the DTTE's letter No. F No. 21(12)/Rectt. Drive / Trg. Admn./2008/PF/697 dated 03.08.2021 returning, inter alia, the applicant's edossier to the respondent DSSSB.
- 2. Set aside / quash the order dated 04.08.2021 as mailed/ issued by the respondent DTTE to the applicant conveying rejection of her offer of appointment.
- 3. Direct the Respondent DSSSB and DTTE to take on record the applicant's experience documents that she had failed to upload by 03.01.2020 due to technical reasons, supra, but duly submitted by her to them as part of her edossier for the post of Craft Instructor Fashion Technology Post code 125/14.
- 4. Direct the Respondents DSSSB and DTTE to keep in abeyance filling up the post of Craft Instructor Fashion Technology Post code 125/14 until disposal of this OA.
- 5. Direct the respondent DSSSB to require the DTTE/ any other user department to make appropriate offer of appointment to the applicant for the post of Craft Instructor Fashion Technology ---Post code 125/14.

WHEREAS, this OA was disposed of on 12.11.2021 with following direction:

"In our considered view, this OA can be disposed of at the admission stage itself by directing the applicant to produce copy of this OA before the competent authority within a period of fifteen days from the date of receipt of copy of this order. The respondents shall, in turn, treat the OA as a comprehensive representation of the applicant, and shall dispose it of by passing a reasoned and speaking order with opportunity to the applicant of being heard, within a period two months thereafter."

WHEREAS, in the instant matter, this office vide letter dated 05.04.2013 sent a requisition, along with performa 001 &002, for the post of Craft Instructors etc. to the DSSSB. In the requisition it was clearly mentioned that for the post of Craft Instructor, Fashion Technology, (Non –Engg.), inter alia, eligibility criteria was 03 years practical experience in the field of concerned trade.

WHEREAS, in year 2014, on basis of said requisition the DSSSB had initiated the process of selection of regular Craft Instructors.

WHEREAS, in Advt. No.1/14 for the Post code 125/14, Craft Instructor, Fashion Technology, against the point (iii) under Essential Qualification; it was, inter alia, mentioned that '3 years practical experience in the field of concerned trade' is required. (Annexure- I)

WHEREAS, vide Result Notice No. 1104 dated 09.07.2020 for the Post code 125/14 issued by DSSSB, it was informed that the applicant bearing Roll No. 3900000114 was provisionally selected to the post of Craft Instructor, Fashion Technology under post code 125/14 in Directorate of Training and Technical Education, GNCTD subject to her fulfilling all other conditions of eligibility and also correctness of the information furnished by her in online application form and e-dossier.

WHEREAS, in the result Notice No. 1104 dated 09.07.2020 issued by the DSSSB, it was explicitly mentioned, against the Roll No. 3900000114 of the applicant that the period of practical experience, which the applicant had uploaded, was w.e.f. 16.07.12 to 30.04.2018 which clearly shows that the experience of the applicant as on 27.02.2014 i.e. the cut off date, was less then stipulated period of 03 years required as per RRs applicable at the time of the issuing of Advt.

WHEREAS to scrutinise the correctness of the all the relevant documents like educational qualification, experience certificates etc. a due process was followed.

WHEREAS at first instance, an internal committee, comprising trade experts also, was formed. This committee had examined all the cases (including applicant's) in the light of 'prevailing RRs at the time of sending requirement to DSSSB in 2013'.

And WHEREAS, the Committee, after thorough examination of the relevant documents in r/o the applicant, had observed that on cut of date i.e. 27.02.2014 her required practical experience was less than 03 years.

WHEREAS further, an external, high powered, committee was formed which meticulously examined all the cases (including Applicant's) and further ratified the findings of the internal committee and in case of the applicant, inter alia, observed 'Not recommended as experience is less than 3 years which is essentially required for non-engg. trade.'

WHEREAS, the Recruitment Rules for Craft Instructor, Fashion Technology lay down, inter alia, essential requirement for eligibility for the post of Craft Instructor that 'candidate must have minimum 3 years' practical experience in the field of trade concerned'.



WHEREAS, In view of the above, it can be asserted that the candidature of the applicant was duly considered and rejected due to non-fulfilment of the eligibility criteria explicitly laid down in the RRs for the post.

Now, therefore, in view of the foregoing, the competent authority has decided that the request of the applicant cannot be acceded to.


