### FIRE SAFETY CERTIFICATE


Certified that the M/s Ghee Wala Guest House located at 4135, Urdu Bazar, Jama Masjid, Delhi, comprised of Ground + 02 upper floors: Ground floor - 06 guest rooms + reception, 1<sup>st</sup> floor - 06 guest rooms + 01 staff room, 2<sup>nd</sup> floor - 04 guest rooms, total 16 guest room was granted Fire Safety Certificate by this department vide letter no. F6/DFS/MS/GH/NDZ/2018/2158 dated 19.09.2018. The building/premises was re-inspected by Assistant Divisional Officer (SPM) from this department on 10.12.2021 in presence of Mr. Moinuddin (Owner) and found that the building has deemed complied with the fire prevention and fire safety requirements in accordance with Rule 33 of Delhi Fire Service Rules, 2010. Accordingly, the premises is fit for occupancy of "Group A-1 (Residential)" for total 16 guest rooms (Ground floor -06 guest rooms, 1<sup>st</sup> floor-06 guest rooms, 2<sup>nd</sup> floor-04 guest rooms) with effect from 20 12 20 21. for a period of three years in accordance with Rule 36 unless renewed under Rule 37 or sooner cancelled under Rule 40 and subject to conditions under Rule

## Conditions for the validity of Fire Safety Certificate:-

- 4. Any deviation w.r.t. construction etc. shall be verified by the concerned building sanctioning authority.
- 5. This fire safety certificate may not be treated in any case for regularization of unauthorized construction, if any.
- 6. The owner / occupier shall submit a declaration every year in form 'K' provided in the first schedule of Delhi Fire Service Rules 2010. The form is available on www.dfs.delhigovt.nic.in.
- 7. The means of escape shall be kept unobstructed / unlocked for unhindered evacuation in case of an emergency.
- 8. The owner/occupier shall apply for renewal of this Fire Safety Certificate to the Director in form 'J' [sub Rule (I) of Rule 37] along with a copy of this Certificate, six month prior to its expiry. Any change in the occupancy shall be intimated to this Deptt. and approval shall be obtained thereto before occupancy of the same.

Note: 02 number of staircases have been required in the guest house and 02 staircases of width 103 and 105 cms have been mentioned provided in the inspection reports 28/N and henceforth. However the same was not found at site. The guest house had already been issued 'NOC' on single staircase on 06.04.1992 vide letter no. F6/DFS/MS/90/GH/2161. The matter of staircase width has already been discussed elaborately at 11/N to 16/N on file and 2<sup>nd</sup> staircase was not required. The area also falls under special area wherein most of the guest houses have been granted NOC/ FSC with single staircase of 80 cms. It appears that the requirement of 02 staircases has been inadvertently mentioned in the inspection reports at 28/N and thereafter and same has been corrected in this inspection report.

The fire protection systems provided in the building were tested, checked at random and found functional at the time of inspection.

If agreed and in view of the deemed compliance of minimum standards of fire prevention and fire safety measures as required under the Rules, the FSC issued vide letter no. F6/DFS/MS/GH/NDZ/2018/2158 dated 19.09.2018 is recommended to be renewed under Rule 35 of the Delhi Fire Service Rules 2010.
