- 5. This Fire Safety Certificate may not be treated in any case for regularizations of unauthorized construction /unauthorized use of land or activities, if any.
- 6. The manager of the school has submitted an undertaking regarding closure of school at second floor since 2016 due to shortage of students. Also in future if the school authorities would start classes at second floor they will seek the permission from this department.

- 8. The owner / occupier shall apply for renewal of this Fire Safety Certificate of the Director in Form 'J' [sub rule (1) of rule (37)] along with a copy of this Certificate, Six Months prior to its expiry.
