Ankur and found that the said guest house building found that stilt -parking , ground floor -05 guest room , 1<sup>st</sup> to third floor -09 guest room at each floor and 4<sup>th</sup> floor not in use & given an affidavit dated 06.02.2020 regarding not to use any floor above third floor, has deemed complied with the fire prevention and fire safety requirements in accordance with rule 33 of the Delhi Fire Service Rules, 2010 and that the premises is fit for occupancy class Residential, Sub Division-A-1 stilt -parking, ground floor (05 guest room), 1<sup>st</sup> to 3<sup>rd</sup> floor -09 guest room at each floor total- 32 guest rooms only with effect from  $237/(-1/2)^{-2}$ ---for period of three years in accordance with rule 36 unless renewed under rule 37 or sooner cancelled under Rule 40 and subject to compliance of the conditions under rule 38 of the Delhi Fire Service Rules 2010, printed below.

- 6. This fire safety certificate may not be treated in any case for regularization of unauthorized construction, if any.
- 7. The owner / occupier shall submit a declaration every year in form 'K' provided in the first schedule of Delhi Fire Service Rules 2010. The form is available on <u>www.dfs.delhigovt.nic.in</u>
- 8. The means of escape shall be kept unobstructed / unlocked for unhindered evacuation in case of an emergency.
- 9. The owner/occupier shall apply for renewal of this Fire Safety Certificate to the Director in form 'J' [sub rule (I) of rule 37] along with a copy of this Certificate, six month prior to its expiry.
