The fire protection system provided in the school building were tested, checked at random and found functional at the time of inspection. Further, the Head of the school apprised in the her letter dated 14.02.2022 placed on opposite side that Navyug School was shifted in ground and first upper floor in 2011 and merged with nursery school (ground and two upper floor) in the year 2017 by removing the boundary wall, consequently the school building becomes ground and two upper floor and no new construction has been made in the school building since 2011. The sanctioned plan of the building is enclosed (C|27 | C|29).

In view of the above and compliance of the minimum standards of fire prevention and fire safety measures as required under the Director Education Circular, if approved, the FSC issued vide letter No. F6/DFS/MS/School/2018/NDZ/1995 dated 30/08/2018 may be renewed for ground two upper floor under Rule 35 of the Delhi Fire Service rules 2010.
