Certified that the **Vivek Guest House** located at **1534-50, Main Bazar, Pahar Ganj, New Delhi** comprised of Ground + 04 Upper floors, Ground floor (04 guest rooms + Reception + 01 Office + lobby + internet cafe), 1<sup>st</sup> floor (11 guest rooms), 2<sup>nd</sup> floor (22 guest rooms), 3<sup>rd</sup> floor (13 guest rooms) and 4<sup>th</sup> floor sealed by MCD, total 50 guest rooms owned/occupied by Vivek Guest House was earlier granted FSC by this department vide letter No.F6/DFS/MS/GH/NDZ/2018/2082 dated 12/09/18. Now, the premise was re-inspected by the officer concerned of this department on 09/03/22 in the presence of Manager and found that the said guest house building comprised of ground , mezzanine ( not a part of guest house ) and four upper floor, **having given an undertaking dated 09.03.2022 regarding not to use any floor above second floor**, has deemed complied with the fire prevention and fire safety requirements in accordance with rule 33 of the Delhi Fire Service Rules, 2010 and that the premises is fit for occupancy class **Residential, Sub Division-A-1 Ground floor (04 guest rooms), 1st floor (11 guest rooms), 2nd floor (22 guest rooms), total 37 guest rooms up to second floor only**, with effect from 15/03/2022 for period of three years in accordance with rule 36 unless renewed under rule 37 or sooner cancelled under Rule 40 and subject to compliance of the conditions under rule 38 of the Delhi Fire Service Rules 2010, printed below.

**Condition for the validity of Fire Safety Certificate**

2. All the fire safety arrangements provided therein shall be maintained in good working conditions at all times. This FSC is valid only for guest house part.
3. Any loss of life or property due to non functional fire safety measures shall be at the responsibility of the management.
4. The trained fire fighting staff should be available round the clock.
5. Any deviation w.r.t. construction etc. shall be verified by the concerned building sanctioning authority.
6. This fire safety certificate may not be treated in any case for regularization of unauthorized construction, if any.

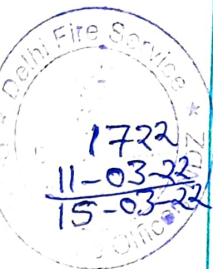

The fire protection systems provided in the building were randomly tested, checked and found functional at the time of inspection. Further, the building is comprised of ground, mezzanine and four upper floor from the beginning and mezzanine floor having separate entry/exit & not a part of guest house. Accordingly we may renew the FSC up to second floor as mezzanine floor is counted as a floor.

In view of the deemed compliance of the minimum standards of fire prevention and fire safety measures as required under the rules, if approved, we may renew the FSC issued vide letter no. F6/DFS/MS/GH/NDZ/2018/2082 dated 12/09/18, renewal under rule 35 of the Delhi Fire Service rules 2010, up to second floor only.
