FIRE SAFETY CERTIFICATE

Certified that the M/s Fatima Guest House located at 775, Gali Imamwali, Motor Market, Jama Masjid, Delhi comprised of Ground + 04 upper floors, Ground floor (Commercial use), 1st floor (reception + 03 guest rooms), 2nd floor (05 guest rooms), 3rd floor (05 guest rooms), total 13 guest rooms was granted FSC by this department vide letter no. F6/DFS/MS/GH/NDZ/2019/786 dated 10.04.2019. The building/premises was re-inspected by Assistant Divisional Officer (SPM) from this department on 19.05.2022 in presence of Mr. Mohd. Parwez (Manager) and found that the building is comprised of ground + 04 upper floors and now the floor wise occupancy is Ground floor – Commercial Use, 1st floor - reception + 03 guest rooms + store, 2nd floor- 03 guest rooms + store, 3rd floor - 02 guest rooms + store + staff room & 4th floor -not in use as per affidavit dated 25.05.2022. The building has deemed complied with the fire prevention and fire safety requirements in accordance with Rule 33 of Delhi Fire Service Rules, 2010. Accordingly, the premises is fit for occupancy class of "Residential Sub Division-A-1, 1st floor (03 guest rooms), 2nd floor (03 guest rooms) & 3rd floor (02 Guest rooms) for total 08 guest rooms only up to third floor with effect from 07/06/2022 for a period of three years in accordance with Rule 36 unless renewed under Rule 37 or sooner cancelled under Rule 40 and subject to conditions under Rule 38 of Delhi Fire Service Rules, 2010 printed below.
