FIRE SAFETY CERTIFICATE

Certified that the **M/s Vakil Guest House** located at **735-739, Motor Market, Jama Masjid, Delhi- 06**, comprised of **Ground + 04 upper floors: ground floor-** (commercial use), **1st floor** - (06 guest rooms + reception + 01 office + 01 waiting room), **2nd floor-** (06 guest rooms + 01 store room + 01 staff room), **3rd floor-** (06 guest rooms + 01 store + 01 staff room) and **4th floor** - (02 rooms), **total 19 guest rooms** was earlier granted FSC by this department vide letter No. F6/DFS/MS/GH/NDZ/2019/2087 dated 31.10.2019. Now, the premise was re-inspected by the officer concerned of this department on 10.08.2022 in presence of Mr. Sarzil (Owner's Son) and found that the building is comprised of ground + 04 upper floors and now the floor wise occupancy is **ground floor** - (commercial use), **1st floor** - (06 guest rooms + reception + office + 01 staff room), **2nd floor** - (07 guest rooms + 01 staff room), **3rd floor** - (06 guest rooms + 01 staff room + 01 store), & **4th floor-** **not in use as per affidavit dated 19.07.2022**. The building has deemed complied with the fire prevention and fire safety requirements in accordance with Rule 33 of Delhi Fire Service Rules, 2010. Accordingly, the premises is fit for occupancy class of "**Residential (Sub Division-A-1), 1st floor (06 guest rooms), 2nd floor (07 guest rooms) & 3rd floor (06 guest rooms) for total 19 guest rooms up to 3rd floor**, only with effect from **11/9/2022** for a period of three years in accordance with Rule 36 unless renewed under Rule 37 or sooner cancelled under Rule 40 and subject to conditions under Rule 38 of Delhi Fire Service Rules, 2010 printed below.

The owner/occupier shall apply for renewal of this Fire Safety Certificate to the Director in form 'J' [sub Rule (I) of Rule 37] along with a copy of this Certificate, six month prior to its expiry. Any change in the occupancy shall be intimated to this Deptt. and approval shall be obtained thereto before occupancy of the same.
