F6/DFS/MS/GH/2018/SZ/1635 dated 13.07.2018. In the Online application no. 2022070414021 dated 05.07.2022 owner of the guest applied for 17 guest rooms (Ground floor – 03 guest rooms, 1st floor – 05 guest rooms, 2nd floor- 05 guest rooms, 3rd floor - 04 guest rooms). The premises was re-inspected by the officer concerned of this department on 26.09.2022 in presence of Mr. Sanjeev Chadha and the floor wise occupancy details were observed as: (Basement- storage, Ground floor - reception + 03 guest room + kitchen, 1st floor – 05 guest rooms + 01 office, 2nd floor- 05 guest rooms + 01 store room, 3rd floor - 04 guest rooms + 01 office. The building has deemed complied with the fire prevention and fire safety requirements in accordance with Rule 33 of Delhi Fire Service Rules, 2010. Accordingly, the premises is fit for occupancy of Group 'A (Residential) sub division A-1, having 17 guest rooms (Ground floor – 03 guest rooms, 1st floor – 05 guest rooms, 2nd floor- 05 guest rooms, 3rd floor - 04 guest rooms), with effect from 29/9/2022 for a period of three years in accordance with rule 36 unless renewed under rule 37 or sooner cancelled under rule 40 and subject to conditions under rule 38 of Delhi Fire service Rules, 2010 printed below

The owner/occupier shall apply for renewal of this Fire Safety Certificate to the Director in form 'J' [sub Rule (I) of Rule 37] along with a copy of this Certificate, six month prior to its expiry. Any change in the occupancy shall be intimated to this Deptt. and approval shall be obtained thereto before occupancy of the same.

The shortcomings issued to the building vide letter no. F6/DFS/MS/GH/2022/SZ/317 dated 29.04.2022 has been rectified by the management.

In view of the deemed compliance of minimum standards of fire prevention and fire safety measures as required under the Rules, the FSC issued vide letter no. F6/DFS/MS/GH/2018/SZ/1635 dated 13.07.2018 is recommended to be renewed under Rule 37 of the Delhi Fire Service Rules 2010.
