F6/DFS/MS/GH/2019/SZ/2082 dated 30.10.2019. The building/premises was re-inspected by Assistant Divisional Officer (M. Road) from this department on 09.09.2022 in presence of Mr. Roshan Lal (Manager) and found that the building is comprised of **Ground + 04 upper floors: Ground floor-** reception + 01 guest room, **1st floor** - 03 guest rooms, **2nd floor-** 03 guest rooms, **3rd floor** - 03 rooms (private use), **4th floor-** 01 room (Sealed). The building has deemed complied with the fire prevention and fire safety requirements in accordance with Rule 33 of Delhi Fire Service Rules, 2010 and the owner has submitted an affidavit on 17.09.2022 not to use any floor above third floor for any purpose in accordance with clarification of Gazette Notification dated 27.05.2019. Accordingly, the premises is fit for occupancy of **"Residential Sub Division-A-1"** for total **07 guest rooms (Ground floor-** reception + 01 guest room, **1st floor** - 03 guest rooms, **2nd floor-** 03 guest rooms) with effect from 26/9/2022 for a period of three years in accordance with Rule 36 unless renewed under Rule 37 or sooner cancelled under Rule 40 and subject to conditions under Rule 38 of Delhi Fire Service Rules, 2010 printed below.
