### FIRE SAFETY CERTIFICATE

Certified that the M/s Atlantic Water World (Khan and Sirohi Electromechanical) located at Khasra no. 463-464, Kalindi Kunj Park, Okhla, New Delhi-25, comprised of ground + 01 upper floor was granted Fire Safety Certificate by this department vide letter no. F.6/DFS/MS//2019/SZ/1290 dated 17.06.2019. The building was re-inspected by Assistant Divisional Officer (M. Road) from this department on 29.09.2022 in the presence of Mr. Rawat (Manager) and found that the building has deemed complied with the fire prevention and fire safety requirements in accordance with Rule 33 of Delhi Fire Service Rules, 2010. Accordingly, the premises/building (ground + 01 upper floor) is fit for occupancy of Group D "Assembly Building" (Amusement Park) with effect from ... at least 12 for a period of three years in accordance with Rule 36 unless renewed under Rule 37 or sooner cancelled under Rule 40 and subject to conditions under Rule 38 of Delhi Fire Service Rules, 2010 printed below.

#### Conditions for the validity of Fire Safety Certificate

- 2. Any loss of life or property due to non functional fire safety measures shall be at the responsibility of the management.
- 3. The trained fire fighting staff should be available round the clock.
- 4. Any deviation w.r.t. construction etc. shall be verified by the concerned building sanctioning authority.
- 5. This fire safety certificate may not be treated in any case for regularization of unauthorized construction, if any.
- 6. The owner / occupier shall submit a declaration every year in form 'K' provided in the first schedule of Delhi Fire Service Rules 2010. The form is available on <a href="www.dfs.delhigovt.nic.in">www.dfs.delhigovt.nic.in</a>
- 7. The owner/occupier shall apply for renewal of this Fire Safety Certificate to the Director in form 'J' [sub rule (I) of rule 37] along with a copy of this Certificate, six month prior to its expiry".
- 8. Any change in the occupancy shall be intimated to this Deptt. and approval shall be obtained thereto before occupancy of the same.

During inspection, the owner informed that the name has been changed from 'M/s Delhi Rides Amusement & Water Park (Khan& Sirohi Electromechanical)' to 'M/s Atlantic Water World (Khan and Sirohi Electromechanical)'.

This is an assembly occupancy mainly consisting of mechanical water riders installed in open area and food court.

The fire protection systems provided in the building were tested, checked at random and found functional at the time of inspections.

The shortcomings issued to the building vide letter no. F6/DFS/MS/Assembly/SZ/2022/2151 dated 26.08.2022 has been rectified by the management.

If agreed to the note above & in view of the deemed compliance of minimum standards of fire prevention and fire safety measures as required under the Rules, the FSC issued vide letter no. F.6/DFS/MS//2019/SZ/1290 dated 17.06.2019 is recommended to be renewed under Rule 37 of the Delhi Fire Service Rules 2010.
