## FIRE SAFETY CERTIFICATE

## Conditions for the validity of Fire Safety Certificate

- 1. Fire safety arrangements shall always be kept under working condition as seen during inspection. Any lapse to maintain the functioning of these equipments shall be the sole responsibility of the owner.
- 2. No other trade is permitted in the same premises along with the fireworks trade.
- 3. Owner shall inform this department before starting his business of fireworks and shall have his basement sealed at the time of business of fireworks.
- 4. The NOC/FSC is valid up to the expiry of the license issued. The reference for inspection and subsequent NOC from fire safety point of view shall be made to this department before renewal of the license, clearly stating the period of license for which license is granted/renewed.
- 5. No other Explosive or alike trade shall be done within 15 meters of this premises.
- 6. The owner / occupier shall submit a declaration every year in form 'K' provided in the first schedule of Delhi Fire Service Rules 2010. The form is available on <u>www.dfs.delhigovt.nic.in</u>
- 7. The owner/occupier shall apply for renewal of this Fire Safety Certificate to the Director in form 'J' [sub rule (I) of rule 37] along with a copy of this Certificate, six month prior to its expiry
