- They will continue to perform the duties of Executive Engineer (Civil)/(E&M), even after getting the designation of Deputy Superintending Engineer (Civil)/(E&M)).
- Their reporting officer will remain the same i.e. concerned SEs/ACEs in they are working.
- Their promotion to the post of Superintending Engineer (Civil)/(E&M) will be governed strictly as per existing notified Recruitment Rules.
- The existing delegation of technical and financial powers delegated to them as Executive Engineer (Civil) & (E&M) as applicable shall remain unchanged.
