**The entrustment on look after charge to the post of Chief Security Officer is subject to final outcome of WP(C)2054/2012, WP(C)3213/2012 pending in Hon'ble High Court of India and following terms & conditions:**

1. The entrustment to look after after charge shall be in his own pay scale of the post he is holding.
2. It will not confer any right on the officer to claim ad-hoc/regular appointment to this post or any other benefit.
3. The period of look after charge will not count as officiating in the higher grade for any purpose.
4. The interim arrangement can be terminated at any time by the Competent Authority without assigning any reason and giving prior notice.
