The following Muster Roll workers engaged on compassionate ground in the year 2012, 2014 and 2016 working on the pay roll of Delhi Jal Board are hereby regularized on their respective posts as mentioned against each, w.e.f the date of regularization as mentioned against each, as per the departmental policy of regularization for Muster Roll Workers engaged on compassionate ground against vacant posts in the **Pay Scale of PB-1 of Rs. 5,200-20,200/- with Grade Pay of Rs. 1,800/-, now Pay Matrix Level-1 under 7th CPC (for Matriculate and above) and Pay Scale of Rs. 4,440-7,440/- with Grade Pay of Rs. 1,300/- (for Non-Matriculate)** plus usual allowances as admissible under the rule, from time to time, on the terms and conditions as per offer of engagement duly accepted by them at the time of engagement to their respective posts on Muster Roll on compassionate ground, after being declared "**Medically Fit**" by the MOIs concerned of DJB and after verification of their educational qualification, caste certificates from the issuing authority and character and past antecedents from the concerned Police Station.

Further, these individuals will continue to work at their present place of posting till further orders.
