A Departmental Compassionate Appointment Screening Committee duly constituted by the Competent Authority held meetings on 04.08.2015 and 11.01.2016 for scrutinizing 603 cases for engagement on muster roll. The recommendations of the Departmental Compassionate Appointment Screening Committee were put up before the Board & the Delhi Jal Board vide its Resolution no. 262 dt: 01.03.2016 accepted and approved the engagement of dependents of the deceased employees on compassionate grounds on muster roll as per the recommendations made by the Departmental Compassionate Appointment Screening Committee. Accordingly, following 52 persons were engaged as PCAMR on muster roll, subject to the conditions that they will have to support the family of the deceased ex-employee of DJB, failing which their services would be terminated without assigning any reason. The engagement was further subject to subject to verification of his Educational and Caste Certificates from the concerned University/School/college/ Board/Institution, verification of Character and past antecedents of the individual by the police & being found medically found fit.

Accordingly, following PCAMRs working on muster roll have completed mandatory requirement of working days, whose verification of educational/caste certificates, Past Antecedents from police and being found medically fit are, hereby, regularized as PCAMR in the Pay Band of Rs. 5200-20200/- plus Grade Pay Rs. 1800/-w.e.f. date mentioned against each:
