Further, it is subject to the term & conditions as mentioned hereunder:-

1. The Entrustment of current duty charge will be in their own pay scale of the post they are holding i.e. Head Security Guard.
2. It will not confer any right on the official to claim for ad-hoc/regular promotion to the post or any other service benefits.
3. The period of service rendered on c-d-c/look after charge will not be counted as officiating or as regular in the higher grade/post for any purpose.
4. The Competent Authority can terminate the interim arrangement at any time without assigning any reason or giving any notice.
5. Other conditions of service will be governed by the relevant rules and orders that may be in force from time to time on the other similarly placed employees of DJB.

6. The officials have to furnish an undertaking to the administration that as and when direct recruited ASOs through DSSSB/any recruiting agency will join DJB they will not object their reposting as Head Security Guard. (Format Enclosed)
7. These officials may be adjusted in future against promotion quota post if the same available.
